MEMORANDUM OF UNDERSTANDING

Between

DSMS Group Of Institutions

And

HEALTHWORLD HOSPITALS

1. Preamble

DSMS Group Of Institutions, Durgapur (hereinafter referred to as the Institute) approached Healthworld Hospitals, situated at C-49, Commercial Area, City Centre, Durgapur - 713216 (hereinafter referred to as Healthworld) and Healthworld has agreed to collaborate through this Memorandum of Understanding and under the terms and conditions hereinafter mentioned.

DSMS Group Of Institutions having its campus at Dr Zakir Hussain Avenue, Bidhannagar, Hudco More, Durgapur-713206, Dist-Paschim Bardhaman (West Bengal) hereinafter referred to as the "institute", represented by Dr Midhu Kurian, (Principal, DSMS Institute of Nursing) and Mrs Moumita Kar (Principal of DSMS College of Tourism and Management) which expression shall unless repugnant to

the context or meaning thereof be deemed to mean and include its successors-inoffice, administrators, executors, legal representatives and permitted assigns).

- Terms and Conditions of Training & Workshops (i.e. Internships/Observership etc):
 - The Hospital will allow the students to undergo internship/observership, participating in Workshops and industrial visit as per schedule as mutually agreed upon.
 - Series of Training workshop will be conducted at Healthworld Hospitals focusing on the speciality fields of various departments such as Surgical ,Paediatric and cardiac Care.
 - Workshop will include both theoretical & practical sessions, allowing students to gain hands on experience under the guidance of experienced healthcare professionals.
 - The workshop will cover a range of topics including but not limited to surgical techniques, paediatric care protocols and cardiac monitoring and intervention.
 - For each Workshop/ Internship assignment based on duration and type of Workshop/Internship, The Institute will send the names of students to Healthworld, reporting for the Workshop/ Internship mentioning the date, period and type of training.
- Students will be required to make their own transport arrangements to the Hospital & back to their place of residence.
- For any Special Workshop/Internships that have a change from the above mentioned arrangements, the same will have to be mutually agreed by both Institute and Healthworld.
- Additionally, seminar can be organised at DSMS Campus by inviting guest lecturer from Healthworld Hospitals. Monthly one Seminar /Workshop can be organised for Management & Nursing students separately.
- Industrial Visit for management students can be allowed once in a year.

B.Sc 3rd year- Clinical Training of 04 months in Cardiac & Pediatric Ward GNM 2nd year- Clinical Training of 04 months in Medical & Pediatric Ward GNM 3rd year- internship of 06 months in all the wards

Internship/Training Fee:

For providing training/internship to student of the Institute, Healthworld shall charge the Institute Rs 15000-/- per student per year as 'Training/Internship Fee'for Nursing students only. Theinstitute shall be liable to pay the Internship/Training fees amount to Healthworld Hospitals within fifteen days from the date of commencement of training/internship.

- Apart from this Rs 1.00L per annum will be paid to Hospital by DSMS Group of Institutions for participating in Workshops, Seminars & arranging Industrial Visits forstudents of management courses as mutually agreed upon.
- The accommodation, conveyance and other personal expenses of the students undergoing training/internship at Healthworld shall not be the responsibility of Healthworld.
- Healthworld shall allow a maximum of twenty (20) students per batch (subject to availability of seats) to undergo training/internship. However, the final permission will be subject to availability of seats in the concerned speciality/stream and consent from the respective Departmental Heads.
- Any change in the training/internship duration shall require amendments of the terms and conditions and agreement of both the parties to the same.
- The following courses/ streams will be covered for internship programme:
 - i. B.Sc. Nursing
 - II. GNM
 - iii. BBA (Hospital Management)
 - iv. MHA
- 4. Both parties understand that this collaboration is solely for the purpose of enhancing students' training & development and no guarantees of placement/work opportunity shall be given by Healthworld.

5. Liability

Except for loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other hereunder.

6. Legal Relationship

This MOU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MOU shall create any legal relationship between the Parties.

7. Commencement, Renewal, Termination

This MOU will be effective from 01-07-2024 for a time period of 02 years. Thismay further be renewed by mutual consent of both parties with a raise of 10% in training fees for another term. Either Party may terminate this MOU by giving 30 days' notice in writing to the other Party.

8. Confidentiality Clause

Healthworld shall not disclose in any manner whatsoever any information regarding the University or students of the university, which may be disclosed during the course of the agreement. Healthworld shall be liable for the safety of students undergoing training at its hospital.

9. This agreement shall be governed by Indian Law and parties hereto submit to the jurisdiction of the courts of Civil Court, Durgapur only.
